**CAUSE OF MINOR SPILL:** After the blockage was removed, it was determined that the causes of this minor spill were hydraulic overload due to heavy rains in the MWA service area and debris. According to the National Weather Service, on April 10<sup>th</sup>, Macon-Bibb received a total of 2.01 inches of rain.

**ESTIMATED VOLUME DISCHARGED:** 5,300 gallons  
*(Please note that this quantity is only a calculated **estimation** of the volume of sewage that spilled from our system. More sewage may have escaped the system.)*

**RECEIVING WATERS:** Ditch feeding Rocky Creek

**SERVICE BASIN AFFECTED:** Lower Rocky Creek

**WRF SERVICE AREA NPDES PERMIT:** GA0024546

**CORRECTIVE ACTION TAKEN TO MITIGATE OR TO REDUCE ADVERSE EFFECTS:** Debris has been removed from the area. The affected area has also been sprayed with an enzyme treatment for organic waste called Bio-Bug.

**SPILL STATUS:** Sewage is no longer escaping.

**SIGNS POSTED:** Thursday, April 11, 2024

**CORRECTIVE ACTION TAKEN TO PREVENT FUTURE SPILL:** A temporary bypass was placed at this location in March 2024. MWA has contacted a contractor to clean the sewer main and investigate approximately 2,500 linear feet which will use CCTV/Sonar to analyze any sediment and possible corrosion.
